## 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** Effects may be delayed. Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If breathing laboured and patient cyanotic (blue), ensure airways are clear and have a qualified person give oxygen through a facemask. If breathing has stopped apply artificial respiration at once. In the event of cardiac arrest, apply external cardiac massage. Seek immediate medical advice.

**Skin Contact:** Effects may be delayed. If skin or hair contact occurs, immediately remove contaminated clothing

and flush skin and hair with running water. Continue flushing with water until advised to stop by the Poisons Information Centre or a Doctor; or for 15 minutes and transport to Doctor or Hospital.

**Eye contact:** If in eyes, hold eyelids apart and flush the eyes continuously with running water. Continue flushing until advised to stop by the Poisons Information Centre or a Doctor; or for at least 15 minutes and transport to Doctor or Hospital.

**Ingestion:** Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink. Never give anything by the mouth to an unconscious patient. If vomiting occurs give further water. Seek medical advice.

## 7. HANDLING AND STORAGE

**Handling:** People handling polyurethane products must have received special training according to guidelines from the National Occupational Health and Safety Board. Persons susceptible to skin sensitisation problems or asthma, allergies, chronic or recurrent respiratory disease should not be employed in any process in which this preparation is being used. Provide sufficient air exchange and/or exhaust in work rooms. Wear personal protective equipment. Do not breathe vapours or spray mist. Avoid contact with skin and eyes. Apply technical measures to comply with the occupational exposure limits (see section 8).

**Storage:** Keep out of the reach of children. Keep at temperatures between 10 and 30 °C. Store in original

container. Keep container closed when not in use. Store in a dry, well ventilated place away from sources of heat, ignition and direct sunlight. Keep away from food, drink and animal feeding stuffs.

## 8. EXPOSURE CONTROLS / PERSONAL PROTECTION

**National occupational exposure limits:** No value assigned for this specific material by WorkSafe New Zealand.

**Biological Limit Values:** As per the WorkSafe New Zealand the ingredients in this material do not have a Biological Limit Allocated.

**Engineering Measures:** Natural ventilation should be adequate under normal use conditions.

**Personal Protection Equipment:** GLOVES, SAFETY GLASSES.

Personal protective equipment (PPE) must be suitable for the nature of the work and any hazard associated with the work as identified by the risk assessment conducted.

Wear gloves, safety glasses. Available information suggests that gloves made from should be suitable for intermittent contact. However, due to variations in glove construction and local conditions, the user should make a final assessment. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storing or re-using.

### RECOMMENDATIONS FOR CONSUMER USE:

No personal respiratory protective equipment normally required. In case of insufficient ventilation wear suitable respiratory equipment. Combination filter: A2-P2. Isocyanates can harden gloves and increase the risk of their splitting. Protective gloves complying with EN 374: Viton®, Neoprene, Nitril rubber, Butyl rubber. Gloves should be discarded and replaced if there is any indication of degradation or chemical breakthrough. Take note of the information given by the producer concerning permeability and break through times, and of special workplace conditions (mechanical strain, duration of contact). Be aware that in daily use the durability of a chemical resistant protective glove can be notably shorter than the break through time measured according to EN 374, due to the numerous outside influences (e.g. temperature). Long sleeved clothing. Remove and wash contaminated clothing before re-use. Ensure that eyewash stations and safety showers are close to the workstation location.

**Hygiene measures:** Repeated or prolonged skin contact may cause skin irritation and/or dermatitis and sensitization of susceptible persons. In the case of sensitisation to any of the ingredients, it is inadvisable to work with the product. Handle in accordance with good industrial hygiene and safety practice. Keep working clothes separately. Keep away from food, drink and animal feedingstuffs. Wash hands before breaks and at the end of workday. When using, do not eat, drink or smoke.

## 10. STABILITY AND REACTIVITY

**Chemical stability:** Stable under recommended storage conditions. Container can be pressurized by carbon

dioxide due to reaction with humid air and/or water.

**Conditions to avoid:** Avoid temperatures above 30°C, direct sunlight and contact with sources of heat. Do not freeze.

**Incompatible materials:** Keep away from oxidising agents, strongly acid or alkaline materials, as well as of amines, alcohols and water.

**Hazardous decomposition products:** In case of fire hazardous decomposition products may be produced such as: Carbon dioxide(CO<sub>2</sub>), carbon monoxide (CO),oxides of nitrogen (NO<sub>x</sub>), dense black smoke. Preparation reacts slowly with water resulting in evolution of CO<sub>2</sub>. Evolution of CO<sub>2</sub> in closed containers causes overpressure and produces a risk of bursting.

**Hazardous reactions:** No reactivity hazards known under recommended storage and use conditions. Polymerises at about 200°C with evolution of CO<sub>2</sub>. Amines and alcohols cause exothermic reactions. Preparation reacts slowly with water resulting in evolution of CO<sub>2</sub>.

## 11. TOXICOLOGICAL INFORMATION

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

### Acute Effects

**Inhalation:** Harmful if inhaled. Material is an irritant to mucous membranes and respiratory tract. A respiratory sensitiser. Can cause possible allergic reactions.

**Skin contact:** Contact with skin will result in irritation. A skin sensitiser. Repeated or prolonged skin contact may lead to allergic contact dermatitis.

**Ingestion:** Swallowing can result in nausea, vomiting and irritation of the gastrointestinal tract.

**Eye contact:** An eye irritant.
